NCELL COMES FORWARD TO DEPOSIT ADVANCE TAX ON BEHALF OF FORMER OWNERS

Kathmandu, 08 May 2016 – Ncell confirmed 08 May 2016 that it had responded positively to the directive of the Large Tax Payers Office ("LTPO") to calculate and make deposit of 15% of the gains of TeliaSonera Norway Nepal Holdings AS ("Telia Norway") arising from the sale of shares of off shore company Reynolds Holdings Limited ("**Reynolds**"), by Telia Norway and its related company group. Reynolds was and is the 80% shareholder of Ncell.

Whilst making the deposit of the advance tax in keeping with the company's commitment to working in close partnership with the government and people of Nepal, Ncell reiterated that the transaction involved the sale of Reynolds shares by Telia Norway, and Ncell had not been involved in the transaction at all, neither has it made any payment or received any payment arising from the transaction.

Ncell is one of the largest taxpayers in Nepal, and has consistently complied with the laws of the country, and have on all occasions exercised the highest standards of governance and compliance pertaining to the fulfilment of tax obligations.

In keeping with its unblemished profile as a responsible corporate citizen committed to the welfare of the people and nation of Nepal, Ncell had decided to extend its fullest cooperation to the Government of Nepal in reaching a resolution of prevailing issues with respect to the levy of Capital Gains Tax. Notwithstanding the fact that the computation and declaration of Capital Gains Tax if any is the responsibility of the Seller of shares, the company had proceeded to place a deposit of advance tax on behalf of the previous owners of Reynolds Holdings.
